13/PCM/02 MINUTES OF LAST MEETING

Minutes of last meeting approved and signed off. Proposed by TI, seconded by GN, all in favour.

13/PCM/03 MATTERS ARISING

PestForce carried out mole work at the Recreation Ground and further work needed but postponed due to Easter Holidays. **TI** presented quote for a new notice board and repair work to existing board in W. Kingston. It was felt this was a reasonable price and should be accepted. Also approval needed to be sought from the Village Hall Committee for new board to be affixed to wall of village hall.

Two Deep Water signs ordered, one for W. Zelston and one for W. Kingston. Clerk contacted DCC Highways with a view to adopting Fingerposts in the village. Awaiting call back from the DCC.

Mr. Piers Chichester contacted re the state of the bottom end of Bagwood Lane and he intimated that this might be due to bad drainage off the fields and would investigate and resolve. Complaints received about the state of Bagwood Lane further up past the T Junction where there is a deep and very large puddle which hardly ever dries out. Clerk to write to Mr. Chichester to ask if this too could be remedied.

With reference to the flooding at Muston and the response from the DCC Highways regarding the work that would need to be done around the culvert to prevent a repeat of the situation which occurred this year, it was decided that the Clerk should write again to the DCC Highways Dept., and push them to commit to some remedial work.

Muston Lane, Anderson was badly hit by flooding over the winter and repair work is planned for the middle of April. Following the email which was received been received that due to budget constraints the available money was to be spent on those properties that had actually been flooded and no money was available for remedial work on Muston Lane, apart from repairing the road surface. A resident, Penny Scott, is collating evidence and photographs of the damage caused by the flooding, copies of which will be given to the Parish Council in order to keep up pressure on DCC and the Environment Agency to carry out remedial work to the river.
