# 1 Public Participation

20.001 It was reported that a resident had planted daffodils on the verge about a meter in front of the gates on the Bere Regis side end of the village. During April/May they had been cut back, thus damaging the potential for future years' growth. The Clerk will check to see who has carried out the cutting and, should it be our contractor, they will be asked to refrain from cutting the daffodil leaves until a suitable time has elapsed.

Village gates — The same resident commented that she felt the village gates, now installed, were so insignificant, you cannot see them, and they would do little to prevent vehicles from speeding. There was a general consensus that the village gates were not as had been anticipated and a full breakdown of the cost would be determined. It was noted that the purpose of the gate is to give motorist the impression of entering a controlled area. It is important that the grass either side of them is kept neat and tidy at all times. The Clerk will contact the contractor and ask him to extend his cutting regime to include a length of verge either side of the signs.

# 10. Traffic Management (HA) - update

20.019 Cllr Andrews reported the team had carried out Speedwatch on the 13<sup>th</sup> May and there seemed to be more speeding than normal. The team were stood at the northern site and it is of concern that they are slowing down past the SID and speeding up as they get to the Greyhound area.

The SID is now in and Cllr Andrews, Mr Andrews and Cllr Langdown have all received training on how it should be installed and when it should be moved. Cllr Langdown is keeping a record of when the SID has to be moved and is taking the recordings from the device.

Cllr Andrews has queried the cost of the village gates as we were told the cost included traffic management and there was not any. All that was put up was a sign. The Clerk has requested a full breakdown of the cost and this should be received within the next fortnight.

20.020 Cllr Luxford reported the Scout camp went well.

The PAT testing is now due and a light needs to be changed in the toilets. Mr Andrews will be asked to deal with both items.

#### 12 Planning Applications & Tree Work Proposals

20.021 To consider planning applications received

2/2019/0425 Mobile home known as Hope Willow, A31 Main Road, Winterborne Zelston Change of use of land to station mobile home to provide temporary accommodation for agricultural worker (retrospective)

Cllr Newman felt they are eligible because they are agricultural workers. Objects on the basis of its location. It is out onto a very dangerous road – the A31. It is close to the river at the rear and there is no provision for the disposal of the chicken waste. The whole application does not seem to make sense. Highways England state that the access is substandard but subsequently state it is a three year trial. There is no evidence of any agriculture taking place on the site – no chickens. The Clerk will submit an objection.

# 13 WK Playground & Recreation Ground

20.022 Cllr Knapp reported that everything is in working order and the site is well maintained.

The recreation ground is being cut weekly but there is some mole activity and the pest controller will be informed. Dog walkers are also respecting the area and clearing up after their dogs.

## 14 Home Watch/Flood Watch (GH)

20.023 <u>Home Watch</u> - Graham Hyde said there was nothing to report.

20.024 <u>Flood Watch</u> – Graham Hyde felt that the chickens at the proposed change of use, will cause issues downstream in Zelston as it is nitrate. The water levels are dropping. He has been in touch with Henry Quinney who is keen to give a presentation to the residents about the geology of the area and the ecology of the site. Cllr Newman suggested that he is invited to a Zelston meeting, especially in lieu of the springs between Kingston and Zelston.

Graham will invite him to attend the June meeting at Zelston.

Rita – the Zelston water levels are dropping and she had recommended that we need to look at the flow of the river as it is silting up a little. She does not wish to stand as flood warden for the coming year.

## 15 Parish Councillors' Reports

20.026 Cllr Knapp reported that a gentleman at Broad Close has complained about the grass cutting to the Synergy contractor on 3<sup>rd</sup> May. The contractor needs to undertake more care and diligence whilst working as the cars are being covered by grass trimmings, dog mess and stones.

Cllr Newman reported that a number of residents have complained about the use of the paddock. It is part of Middle Farm and it is intended that it will be used for different events. It is being advertised for weddings and other events up to 1am. Nothing has happened on the site to date. The other issue raised is, because the price of hiring the field is low, they are concerned that travellers may use the field and not leave. We will monitor the situation.

Cllr Andrews reported that the Kingston kiosk is now finished. Derek Andrews has made a very good job of the refurbishment. Our grateful thanks are given to both Helen and Derek for all the work they have done to bring this about.

The river opposite the Greyhound is very untidy and needs clearing. The verge outside Plumbley Meadows needs to be cut. The hedge coming out of Church Street is also overgrown and causing visibility issues and is encroaching on the path.

White Post junction continues to be an issue. Cllr Andrews suggested the speed limit is reduced to 40mph down through the area. This will be put on the agenda for discussion at the June meeting.

Cllr Langdown reported that the SID is working well. He asked if we could write to Wyatt Homes and ask them to remove their Oakborn signs from around the village. The brambles at the new orchard have been sprayed three times.
